Why do we need to think about Care Leavers?

'Those with experience of the care system are more likely to have experienced significant trauma and abuse and other disadvantage that can put them more at risk of violence, self-harm and suicide when in prison. Many also have experiences of being failed by their corporate parents and can come to prison feeling extremely isolated and angry.'

(Farmer Review, 2017)

- 27% of the prison population have spent some time in care, despite the fact that only 1% of under 18s enter local authority care annually.
- It is likely that around a quarter of 18-25 year olds in your establishment are defined as Care Leavers.
- Care leavers are more likely to be reconvicted or breached when they leave custody (MoJ, 2013).
- Care leavers are some of the most vulnerable individuals you will be working with in custody, many will have experienced significant trauma during their childhoods which will impact on their physical and mental health, as well as their behaviour.
- Looked after children and care leavers are between four and five times more likely to attempt suicide in adulthood.
- The prison service are committed to providing effective support to Care Leavers in custody:

'HMPPS will provide a framework of provision and policies that together, will work to improve the life-chances of care leavers once in the community'

Understanding Care Leaver Needs

Stigma and labels

Some young people may have had a negative experience of the care system and do not want to be associated with being a Care Leaver. Many young people consider 'Care Leaver' a negative label that carries stigma associated with challenging behaviour and poor attainment. Care Leavers need support to understand the benefits of identifying themselves as a Care Leaver; have the opportunity to speak about their care experience; and be made aware that staff understand the challenges they might have faced.

Lack of influence over decision making

During their time in care, young people may have felt that decision making processes were taken out of their hands - they have felt like nobody listened to them when decisions were made to remove them from a family home, move placement or leave care. Care Leavers may need support to share their views and trust that their views are being listened to.

Transition to adulthood

18 often feels like a 'cliff edge' for Care Leavers with a rapid transition to independent living and adult services, often lacking the emotional, practical and financial support that other young people have access to when they leave home. They may need additional support to develop independent living skills prior to release. A third of all Care Leavers leave care before their 18th birthday.

Education, training and employment

Unfortunately, research suggests that Care Leavers are far less likely to achieve well in education than their peers. In 2013, only 27% of children in care had achieved 5 GCSE's compared to 80% of non-looked after children (DfE, 2013). As a result, Care Leavers in custody may need additional support and encouragement to access education and training.

Health needs

The impact of trauma and maltreatment in childhood (63% of children enter care as a result of abuse or neglect) places Care Leavers at risk of poor physical and mental health. It can also impact on their ability to self-regulate their feelings and behaviour. For many Care Leavers, their physical and mental health needs may not have been diagnosed or treated due to lack of support networks or regular placement moves.

Relationships

Previous trauma/disrupted attachment, changes in caregiving arrangements, involvement of numerous agencies in their lives, inconsistency in PA/social worker may make it difficult for Care Leavers to develop and maintain positive relationships. It may take longer to overcome the barriers that many individuals put up to prevent trusting relationships being developed. They may display behaviour that makes it difficult to develop those relationships. However, it is important to remind yourself why it is that these young people may find relationships difficult and let them know that you will keep trying. Consistency and perseverance are key.

How to define a Care Leaver

The definition 'Care Leaver' dictates what support an individual will be able to access from the Local Authority who was responsible for caring for them.

Care Leaver status is defined by:

- The age the individual is now (they must be 25 or under)
- The age the individual was in care (they must have been in care on their 16th birthday)
- How long the individual was in care for (they must have been in care for at least 13 weeks since their 14th birthday to be eligible for full support from the local authority)

The chart below tells you who is defined as a Care Leaver and the type of support they are eligible for from local authorities.

To confirm an individuals' care leaver status contact the local authority that was responsible for their care – a list of authorities and contact numbers can be found on pages 12-21.

Important to remember:

- Many individuals' may be 'care experienced' even if they do not meet the 'Care Leaver' criteria. They may have support needs as a result of their care experience.
- Unaccompanied asylum-seeking children will automatically be in the care of the Local Authority on arrival to the UK. On 31st March 2018 there were 4,480 unaccompanied asylum-seeking children in England.
- 'Care Leaver' is a label that some individuals may not feel comfortable with. Many young people did not choose to 'leave care' and instead feel that 'care' left them. Young people often feel there is a stigma associated with the 'Care Leaver' label.
- Some individuals may choose not to have contact with their Personal Advisor, others may not know who their Personal Advisor is.
- Some individuals may not be aware of their 'Care Leaver' status you may need to ask a series of questions to ascertain whether they are a Care Leaver.
- The length of time and the age at which they were in care will define what support from the local authority they are entitled to. This will NOT necessarily define what support they require.

Jargon Busting

Advocate

Young people in care are legally entitled to an advocate who will help make sure their voice is heard in decisions that affect them as well as help them to make a complaint and ensure that they are receiving the support they are entitled to. Advocates usually work for independent organisations, whereas Children's Rights Officers work for the council. There are also advocacy services available for Care Leavers – see resource list on pages 22-25.

Corporate parent

A corporate parent is intended to carry out many of the roles a parent would. It is the local authority's role to be the corporate parent for Care Leavers. They should provide the child they are responsible for with the best possible support and care and safeguard them from harm. For care leavers this responsibility continues until their 21st birthday with this continuing until they are 25 should they want it. They are also able to ask for it at any point until they are 25.

Local Offer

All local authorities have to publish a 'Local Offer for Care Leavers' which details what support they are providing for Care Leavers and how that support can be accessed. It should include who to contact to access support and where to go for support with; health and wellbeing, relationships, education, employment, housing and finance. Most of these offers are published on-line (links listed in Local Authority contacts, pages 12-21).

Pathway Plan

Local Authorities *must* develop a Pathway Plan with a young person in care sometime after their 15th birthday, usually around their 16th birthday, to support them to live independently. This Plan, based on a needs assessment, covers all aspects of a Care Leaver's life from relationships, health and identity to independent living skills, employment and housing. The Plan should include details about how the PA and Care Leaver will stay in touch. Much of the information included may help inform an individual's Sentence and/or Resettlement Plan while they are in custody.


Personal Advisor (PA)

Once a young person in care is over 16, or a Care Leaver they will be appointed a Personal Advisor (PA). The PA will take over from the Social Workers in supporting the young person to live independently, developing/reviewing Pathway Plans until that individual is 21 (and up to 25 if an individual requests this). In some cases a young persons' PA may have also been their social worker. PAs should stay in regular contact, and support young people with accessing education, training and employment and provide advice on things like housing, money, health, relationships and wellbeing.

Support available for Care Leavers

Personal Advisor

Up until the age of 21 (and 25 if requested by the young person), PA's should visit Care Leavers in custody regularly to review their **Pathway Plans** and ensure they have access to the support they are eligible for (as identified in **Local Offer**) from the local authority upon release.



TIP: The best place to find out about what support is available for a Care Leaver is to check out the local authority Local Offer or speak to their Personal Advisor – see contact details on the following pages.

List of Local Authority Care Team Contact Numbers & Local Offers

You might contact a local authority (with a young persons' permission) to:

- Identify/contact a Personal Advisor/social worker for a Care Leaver in custody
- Check a young persons' Care Leaver status
- Engage local authority in resettlement/sentence planning for a Care Leaver
- Inform the local authority that a Care Leaver is in custody
- Help to identify significant others/family members for a Care Leaver

You might access a local offer to:

- Identify support/services available to care leavers in that area
- Share information with a Care Leaver about the range of support available. Many local offers are written as colourful leaflets that are accessible to young people (see links below). It may be useful for a Care Leaver to go through the local offer before they meet with their Personal Advisor.
- Identify contact details of services/individuals within the local authority.
